WHEREAS, Adirondack Contracting, Inc. of Sea Girt, New Jersey submitted a proposal which proposed price was advantageous to the Authority, and which proposal conformed to all requirements; and

WHEREAS, Adirondack performed such services for the Authority in the past and has proven to be a competent and reliable contractor; and

WHEREAS, sufficient funds are available from the Authority's operating funds to pay for the required services;

The following resolution was introduced by Commissioner Gonzalez, read in full and considered:

RESOLUTION NO. _3387-21_

RESOLUTION TO ACCEPT EMERGENCY HOUSING VOUCHERS

WHEREAS, this is to recommend approval of an initial funding award of \$331,452 for 31 Emergency Housing Vouchers (EHV) authorized by the American Rescue Plan Act. The American Rescue Plan Act allowed the Department of Housing and Urban Development (HUD) to allocate additional vouchers to PHAs through an allocation formula designed to direct emergency vouchers to the PHAs operating in areas where the EHV's eligible populations have the greatest need while also taking into account PHA capacity; and

WHEREAS, HUD determined Perth Amboy Housing Authority could successfully administer the vouchers based on the size of our current voucher program and our ability to maintain a very high leasing percentage; and

WHEREAS, the effective date of the award will be July 1, 2021. The vouchers may continue to be reissued upon turnover until September 30, 2023; and

WHEREAS, the EHV s are provided to help assist individuals and families who are (1) homeless, (2) at risk of homelessness, (3) fleeing, or attempting to flee, domestic violence, dating violence, sexual assault, stalking, or human trafficking, or (4) recently homeless. The Authority will notify its current applicants to determine if they meet the criteria for assistance under the EHV program. The Authority will partner with the Middlesex County Continuum of Care (COC) to determine how best to target the vouchers, determine if any of our current applicants meet the eligibility requirements, obtain referrals of families in need, and coordinate services to assist the families receiving vouchers. Referrals may also come from Domestic Violence (DV) homeless shelter providers who maintain their own database to protect the identities of domestic violence survivors. The Authority will maintain a separate waiting list for this program; and

WHEREAS, the 2021 annual Point in Time (PIT) count of homelessness in Middlesex County indicated there are 457 homeless households in Middlesex County. Forty-two households last had permanent residence in Perth Amboy. In addition to the 31 vouchers received by Perth Amboy Housing Authority, it is estimated the NJ DCA will allocate between 30-70 EHV vouchers to Middlesex County. Our initial assessment is the EHV vouchers would probably be best utilized for households that don't need the offer of extensive supportive services, but also are likely to need long term rental assistance. This might include single parent households with very low income and disabled and/or elderly fixed income households. However, no decisions have yet been made as to how to use the vouchers; and

WHEREAS, the Authority will receive between \$750 and \$1,250 in additional one time administrative fees per unit over the usual administrative fees earned in the regular voucher program. There will also be \$3,500 per unit designated to pay for eligible expenses on behalf of the participating families. These services may include, but are not limited to, housing search assistance, security deposits, utility deposits, rental application fees, moving expenses, tenant-readiness services to address barriers to successful lease-up, renter's insurance, essential household items, and landlord incentives. The Authority may need to provide stipends to some employees from the additional administrative fees in the event the initial lease up of the vouchers requires extra hours;

NOW THEREFORE BE IT RESOLVED by the Board of the Authority as follows:

The Authority accepts approval of an initial funding award of \$331,452 for 31 Emergency Housing Vouchers (EHV) authorized by the American Rescue Plan Act, as presented.
