Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Progress on Goals:

PHA Goal: To convert 60 Public Housing units to the Rental Assistance Demonstration Program

The Authority closed on the 29 units at Willow Pond (NJ006000014) in 2021. All tenants were converted to RAD PBV effective 9/1/21. The remaining 31 public housing units at Parkview (NJ006000013) closed 3/31/22 ahead of the PAHA's 4/1/22 fiscal year start. This goal is complete.

PHA Goal: Low Income Housing Tax Credit Compliance

Staff continues to work with the Dunlap and Hansen RAD investors to ensure all 360 files are IRS compliant. The RAD tenant files are monitored and audited on an annual basis. Training for administrative and maintenance staff continues annually. The tenant files and properties will continue to be audited and inspected by PNC and the NJ HMFA. This goal has been met, and activities are on-going.

PHA Goal: Property Management Policies and Procedures

Property management staff and maintenance supervisors continue to review and revise all procedures to ensure compliance with RAD/PBV regulations, develop maintenance and preventive maintenance protocols, and focus efforts on tenant lease compliance. During 2022 the parking lot at Otlowski Gardens (Dunlap RAD) was restriped and parking permits issued. Enforcement of the parking policy is on-going. This has cut down on complaints of a lack of parking and served to enforce the lease against illegal borders at the property. Staff also worked toward getting tenants caught up on rent payments and enforced the eviction process now that evictions have resumed post COVID-19 restrictions. Staff will continue working on this goal in 2023. This goal is on-going.

PHA Goal: Housing Choice Voucher and Project Based Voucher Policy Development and Implementation The Authority continues to update this policy on an as needed basis. The Authority plans to revise the entire policy. This goal is on-going.

PHA Goal-Housing Choice Voucher Participant Program Compliance: This effort is on-going. It will be supported by the update in program policies and procedures as stated above.

PHA Goal: Staff Development

The Authority continues to assess staff training needs and provide training and continuing education on an annual basis. Several staff members received certifications in LIHTC and HCV Specialist this year. Staff continue to be cross trained and prepared to take on more responsibility/opportunities. The Authority continues to prepare for staff retirements and resignations. This activity is on-going.

The Personnel Policy will be reviewed and revised on an annual basis. In 2022 the employee handbook was revised for PARTNER staff. Changes in personnel policies were also implemented for cyber security.

PHA Goal: Technology

The Authority successfully implemented on-line application processing for both the RAD PBV and HCV programs in 2022. Applicants applied on-line and can submit documentation, update their applications, and see their waiting list status through the portal. HCV staff began using web based document storage to increase efficiency in operations.

In 2023 the Authority will focus on increasing use of the on-line tenant portals by participants and tenants to submit recertification documents. The authority also has to implement the HCV landlord portal, and implement the rent pay and work order portion of the tenant portals. Technology improvements remain on-going. Staff will attend training hosted by our tenant software vendor in April 2023.

PHA Goal: Waiting Lists

The Authority reopened the waiting lists for the PBV and HCV programs during 2022. This goal is complete.

PHA Goal: Promote self-sufficiency and asset development of assisted households

The Authority successfully received several additional private grants, as well as an increase in its FSS grant from HUD, to continue supporting the program size of at least 75 participants. The Authority had 88 families under FSS contract during FYE 3/31/23.

PHA Goal: Increase assisted housing choices - Provide homeownership opportunities to families.

Not less than 2 new participants will be attracted annually into the Section 8 Voucher Homeownership Program. While this goal has been met in prior years, there have been no new homeowners this year. This goal is on-going.

The Housing Authority's Five-Year and Annual Plan are posted on the Authority's website. RAB comments and challenges to the plan are pending.
