Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Progress on Goals:

PHA Goal: To convert 60 Public Housing units to the Rental Assistance Demonstration Program

The Authority closed on the 29 units at Willow Pond (NJ006000014) in 2021. All tenants were converted to RAD PBV effective 9/1/21. The remaining 31 units at Parkview (NJ006000013) are scheduled to close 3/1/22 ahead of the PAHA's 4/1/22 fiscal year start.

PHA Goal: Low Income Housing Tax Credit Compliance

Staff continues to work with the Dunlap and Hansen RAD investors to ensure all 360 files are IRS compliant. The RAD tenant files are monitored and audited on an annual basis. Training for administrative and maintenance staff continues annually. The tenant files and properties will continue to be audited and inspected by PNC and the NJ HMFA. This goal has been met, and activities are on-going.

PHA Goal: Property Management Policies and Procedures

Property management staff and maintenance supervisors will review and revise all procedures to ensure compliance with RAD/PBV regulations, develop maintenance and preventive maintenance protocols, and focus efforts on tenant lease compliance. Progress on this goal was paused due to COVID-19. Changes in procedures were made in response to COVID-19. The RAD staff hopes to continue working on this goal in 2021. This goal is on-going. Responding to COVID-19 remains the top priority.

PHA Goal: Housing Choice Voucher and Project Based Voucher Policy Development and Implementation The Authority continues to update this policy on an as needed basis. In 2020, The Policy was updated in accordance with the COVID-19 waivers. This goal is pending.

PHA Goal-Housing Choice Voucher Participant Program Compliance: This effort is on-going. It will be supported by the update in program policies and procedures as stated above.

PHA Goal: Staff Development

The Authority will assess staff training needs and provide training and continuing education on an annual basis. Staff will be cross trained and prepared to take on more responsibility/opportunities. The Authority continues to prepare for staff retirements and resignations. This activity is on-going.

The Personnel Policy will be reviewed and revised on an annual basis. In 2020 and 2021 personnel procedures have been developed and training conducted to respond to COVID-19. This goal is on-going. COVID policies remain the priority.

PHA Goal: Technology

The Authority will implement on-line application processing and web based document storage to increase efficiency in operations. The Authority will upgrade its computer hardware and software over the next five years.

Progress on this goal continues. COVID-19 created an urgent need to accelerate implementation of online technologies to conduct program tasks including zoom meetings, briefings, hearings; on-line application processing and on-line rent payment. Most activities are complete. The Authority will add on-line work orders, waiting lists, rent payment, and recertifications in 2022 through our tenant software vendor.

PHA Goal: Waiting Lists

The Authority will reopen waiting lists for the PBV and HCV programs over the next five years. The PBV programs will have site based waiting lists, and the HCV waiting list will be program wide. This goal is on-going. This will be accomplished in 2022.

PHA Goal: Promote self-sufficiency and asset development of assisted households

The Authority will continue to seek outside funding to supplement its FSS grant so that it can maintain a program size of 75 participants. The Authority has successfully maintained 75 participants.

PHA Goal: Increase assisted housing choices - Provide homeownership opportunities to families.

Not less than 2 new participants will be attracted annually into the Section 8 Voucher Homeownership Program. This goal is on-going and has been met despite the pandemic.

The Housing Authority's Five-Year and Annual Plan are posted on the Authority's website. RAB comments and challenges to the plan are pending.

3. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Resident Advisory Board or Boards in developing the Plan, including any changes or revisions to the policies and programs identified in the Plan before they were implemented, and considered the recommendations of the RAB (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
4. The PHA provides assurance as part of this certification that:
 - (i) The Resident Advisory Board had an opportunity to review and comment on the changes to the policies and programs before implementation by the PHA;

5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
6. The PHA certifies that it will carry out the public housing program of the agency in conformity with title VI of the Civil Rights Act of 1964 (42 U.S.C. 2000d-2000d-4), the Fair Housing Act (42 U.S.C. 3601-19), Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794), title II of the Americans with Disabilities Act (42 U.S.C. 12101 et seq.), and other applicable civil rights requirements and that it will affirmatively further fair housing in the administration of the program. In addition, if it administers a Housing Choice Voucher Program, the PHA certifies that it will administer the program in conformity with the Fair Housing Act, title VI of the Civil Rights Act of 1964, Section 504 of the Rehabilitation Act of 1973, title II of the Americans with Disabilities Act, and other applicable civil rights requirements, and that it will affirmatively further fair housing in the administration of the program.
7.  12. The PHA will comply with the requirements of Section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
 13. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.
 14. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
 15. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
 16. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
 17. The PHA will keep records in accordance with 2 CFR 200.333 and facilitate an effective audit to determine compliance with program requirements.
 18. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
 19. The PHA will comply with the policies, guidelines, and requirements of 2 CFR Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Financial Assistance, including but not limited to submitting the assurances required under 24 CFR §§ 1.5, 3.115, 8.50, and 107.25 by submitting an SF-424, including the required assurances in SF-424B or D, as applicable.
 20. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
 21. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.
